### DATA COLLECTION

All forms on this website that request personal information will ask for the users' consent for their data to be treated and processed by CPA FERRERE. The forms will indicate the purpose for which information is being gathered and identify the data controller for the database in which it will be included.

In no case will you be obliged to provide the information requested. However, certain data may be necessary to receive the service or information requested or to participate in personnel selection processes, without which it may be impossible to provide same.

All forms will include a box for you to indicate your acceptance of the conditions under which you provide information. Clicking on that box will be considered your express acceptance of these privacy policies and your consent for CPA FERRERE to incorporate and process the information entered on the form.

### DATA RETENTION

CPA FERRERE shall retain personal data only for the period of time necessary to perform the activity for which such data was obtained.

Data shall be eliminated from all the firm's systems when they have ceased to be necessary for the purpose for which they were obtained and when their retention is not required or authorized by any legal provision.

### DATA PROCESSING

CPA FERRERE shall process your data in full compliance with applicable rules and in accordance with these policies. At no time shall your personal data be used for activities other than those to which you consented unless you expressly authorize us to do so.

### DATA SECURITY AND CONFIDENTIALITY

The personal data provided to CPA FERRERE are treated with utmost security and confidentiality. CPA FERRERE adopts all appropriate security measures to ensure privacy and security in retaining your data.

CPA FERRERE maintains the confidentiality of personal data that users and clients decide to provide on the website, in compliance with legal provisions on personal data protection in Uruguay, unless such data is required by law or judicial or administrative order.

## **USE OF COOKIES**

CPA FERRERE may use cookies on its website. Cookies are small text files that the websites you visit place on your computer hard drive.
